# Rural Municipality of Whiska Creek No. 106 Bylaw No. 201 - 2023 A Bylaw to Authorize a Special Tax for Street Lights

The Council of the Rural Municipality of Whiska Creek No. 106 of the Province of Saskatchewan, enacts as follows:

- 1. A Special Tax be levied against all benefiting lands, as per Appendix A, for the service of street lights to be completed within the current year.
- 2. The service of street lights is hereby authorized on:
  a) within the boundaries of the Hamlet of Pambrun
- 3. The estimated cost of the street light service is three thousand three hundred dollars (\$3,300).
- 4. The tax rate is sixty dollars (\$60) per residential dwelling or commercial property to be levied against all owners of land according to their respective residential dwelling or commercial property.
- 5. Any person who considers that an error or omission was made in the application or calculation of the special tax on his or her property may notify the municipality in writing by August 31, 2023 requesting the council to review the application or calculation of the tax rate regarding the property in question.
- 6. The administrator will notify the persons, who have requested a review, of the time and date the council will meet to hear and review the requests.
- 7. The taxes that are levied will be added to the tax roll as a special assessment against the property, when they become due and payable, and are recoverable in the same manner as other taxes.

8. Bylaw No. 192 – 2022, passed June 20, 2022, being a bylaw to authorize a special tax for streetlights, is hereby repealed.
